## Primary Narrative By Caleb Bucy

On April 10, 2025 at 2:32 PM, Fort Mill Deputies responded to the Beansprout academy at 3070 Pleasant Road in

Fort Mill, York County 29708 to a reported man on the school property carrying a rifle. Over the past two days there had been multiple phone calls to the Sheriff's Office regarding this subject walking in the area armed with a rifle. During those calls a citizen was able to identify this subject as Mr. Jaylen Reid, and provided a photograph. Mr. Reid had an active warrant for his arrest with the Sheriff's Office, which all the responding Fort Mill deputies were aware of. Deputy Duckett, and Deputy Richard were the first two units in the area. Deputy Duckett was waved down by a citizen who pointed out a walking path that Mr. Reid had went down, away from the school. Deputy Duckett, and Deputy Richard got out on foot moving down the path until Deputy Duckett saw Mr. Reid, and challenged him. Deputy Duckett identified himself as a police officer, and told Mr. Reid to stop.

Mr. Reid took off running from Deputy Duckett, and Deputy Richard, crossing over Pleasant Road going toward the Publix grocery store at 928 Gold Hill Road. Deputy Duckett, and Deputy Richard chased Mr. Reid on foot into the Publix grocery store. Mr. Reid fled across the front of the store before locking himself in the employee office, where the public is not welcome. Deputy Duckett called the other deputies to his location, while informing civilians to move away from the area. Sgt. Bucy arrived on scene, and Deputy Duckett pointed out the office where he had seen Mr. Reid go inside. The deputies advanced on the room with their pistols drawn, and giving loud commands for Mr. Reid to show is hands. There was a small window in the office door that Deputies could see Mr. Reid who did place his hands over his head, but the gun was not visible, and he refused to come out. Sgt. Bucy moved forward, and attempted to open the office door, but it was locked from the inside. Sgt. Bucy, and Deputy Duckett continued to give commands for Mr. Reid to open the office door that Deputy Duckett continued to give commands for Mr. Reid to open the door, which he did not immediately do.

After a short standoff Mr. Reid opened the door from the inside, Sgt. Bucy holstered his pistol, and pulled Mr. Reid out into the small hallway. Sgt. Bucy, and Deputy Duckett then each grabbed one of Mr. Reid's arms, while instructing him to take off his backpack before being handcuffed. When deputies attempted to take off his bag, Mr. Reid pulled, and tensed his arms in an attempt to further resist his arrest. Sgt. Bucy, and Deputy Duckett then forced Mr. Reid to the ground, causing the rifle that was hooked to Mr. Reid on a sling to lay on the ground. Deputy Duckett kneeled on the rifle to prevent its access, while Deputy Richard, and Deputy Twargoski assisted in removing the backpack then handcuffing Mr. Reid. Once Mr. Reid was handcuffed, and the rifle secured, Sgt. Bucy advised Mr. Reid of his Miranda Rights. Sgt. Bucy asked what Mr. Reid's name was which he said was "Allah, Allah". Sgt. Bucy asked if he also went by Jaylen Reid, which Mr. Reid confirmed was his name. Sgt. Bucy then requested dispatch to get Mr. Reid's active arrest warrant in hand. Deputies did an additional Terry Frisk of Mr. Reid, and found a revolver, extra extended magazines for the rifle, and loose bullets on his person.

After securing the second gun Sgt. Bucy said to Mr. Reid that he had an active warrant for his arrest, which Mr. Reid said he had called the Sheriff's Office to have that warrant withdrawn. Mr. Reid was escorted outside, and informed he was under arrest. After being searched incident to arrest Mr. Reid was seated in the back of Deputy Twargoski's car, escorted to the detention center, and transferred into detention staff custody. The guns, and ammunition were seized, and entered into evidence. Warrants for Possession of a Gun on School Grounds, Resisting arrest, and Trespassing were obtained, and served to Mr. Reid.
